[2.1] Statutory Basis

[2.2] Organizational Structure

Three-Tier System:

1. **University-Level Council**
 - Oversees all student activities
 - Composed of elected representatives from all faculties
2. **Faculty/Institute Committees**



- 7 specialized committees per faculty (Cultural, Sports, etc.)

3. Activity-Specific Teams

- Task forces for individual initiatives
